

# **ROADMAP TO PRACTICE IN BC – LICENSURE AND INSURANCE**

## 1. COLLEGE OF CHIROPRACTORS OF BC

The College of Chiropractors of British Columbia (CCBC) is BC's regulatory body that licenses chiropractors, sets and enforces standards of practice to protect the public.

You will need your CCBC license number for your CCA and CCPA membership applications

Estimated processing time: minimum 4 weeks from submission of application and all documents

#### The British Columbia Chiropractic Association (BCCA) is your professional membership association. Our role is to advance the chiropractic profession through advocacy, promotion, and support.

When your membership application is **Conditionally Approved**, you'll receive an email inviting you back into the portal to complete the application.

BCCA offers dues sponsorship for new graduates (<u>New Grad Terms & Conditions</u>). Those who choose to take advantage of sponsorship must enroll in the BCCA Pre-Authorized Payment program. This includes submitting a PAP form and VOID cheque.

Note: You can apply to BCCA as soon as your application is complete with CCBC

BCCA will communicate application status to CCA and CCPA, confirmation of CCPA membership to CCBC, and confirmation of licensure to CCPA.

Estimated processing time: 7 business days from application completion to active practice
